e-Krediidiinfo is Estonia's largest business information portal, which allows you to get the information you need for business quickly and conveniently from one place. To join the portal, you can choose between Pro and Pro XL packages.

As a customer of e-Krediidiinfo, you can:

- Access to discounted detailed reports
- Ability to enter payment defaults of companies and individuals in to the Payment Default Register
- Ability to use monitoring and credit risk management service
- If necessary, check the background of your clients on the sanctions lists or make sure that they are not a person with a national background (PEP)

Each client can appoint an administrator from among its users who can manage the rights of all users. The number of e-Krediidiinfo users is not limited.





Pro package

The pro package allows you to view the following information about all Estonian companies:

- Interrelationships between individuals and companies in a visualized form
- Valid persons with the right of representation, shareholders/partners and beneficial owners in the business register
- The actual beneficiary in the business register
- Subsidiaries and affiliates
- Valid data about council members and other connected persons
- Contact information
- Main field of activity, activity permits and economic activity notifications
- Turnover, declared in the last quarter (Tax and Customs Board)
- Taxes paid in the last quarter
- Balance of claims of the Tax and Customs Board
- Number of employees in the last quarter (Tax and Customs Board)
- Property information

The subscription fee for the pro package is €50 (without VAT)..



Pro XL package

The Pro XL package contains the following information about all Estonian companies

- Contact information
- Main activity
- Turnover, declared in the last quarter (Tax and Customs Board)
- Persons with the right of representation are shareholders/partners and beneficial owners in the commercial register
- Subsidiaries and affiliates
- Council members and other persons are valid
- Former related parties

In addition to the business register data, the Pro XL package includes:

- Interrelationships between individuals and companies in a visualized form
- Key financial indicators from the annual report and trends
- Payment default register information (valid and terminated payment defaults)
- Tax debts in real time with 4 years of tax debt history
- Paid taxes in the last quarter with history
- Number of employees in the last quarter and data of the last 13 quarters (Tax and Customs Board)
- Actual Beneficiary of Creditinfo calculated based on the ownership structure of the business register
- Activity permits and economic activity notifications
- State subsidies (EAS and PRIA)
- Official announcements
- Property information
- Media coverage

The price of the Pro XL package is personal to each customer and is formed based on the customer's needs.
